4. Details of our assessment

Natural Resources Wales senior industry and waste regulation officers Carter Shone and Phil Harper visited Bimeda on the 23rd of November 2023. This was a pre-arranged familiarisation visit and site inspection accompanied by the site manager, quality manager, and the site engineer.

At the time of inspection, the bolus production line was not operational due to preventative maintenance being carried out.

Permitted activities

An in depth tour of the facility and the operation were provided. The sites abatement systems include an afterburner on the kiln and dust collection system.

The afterburner was visually inspected, and the site engineer talked through there maintenance schedule and procedures. The temperature monitoring records were checked and showed that a temperature of higher than 800 °C had been maintained which is specified in the permit.

The dust extraction system was under preventative maintenance that was identified in the operators scheduled checks.

The operator showed that they have gained the Green dragon level 3 award showing that they possess a certified environmental management system.

The site

The site appeared to be tidy and well maintained. All secondary containment was in good condition.

All incoming raw materials are properly stored and labelled.

No offsite odours were noted during the inspection.

Offsite noise was not deemed to be excessive
