4. Details of our assessment

On the 13th November 2023 a site inspection and hazardous waste audit were undertaken at Qioptiq Ltd, Glascoed Road, Saint Asaph, LL17 0LL by NRW officers Phil Harper and Carter Shone (Senior Industry & Waste Regulation).

Site Inspection

At the time of the inspection the site was operational. Permitted emission points have now been clearly identified using labels and the sampling ports A2, A7 and A11 have been modified to include sealed access ports. No compliance issues were identified at the site.

Hazardous Waste Audit.

A hazardous waste audit was undertaken during the visit. As part of the hazardous waste audit a site tour was provided to view the current waste storage facilities. All wastes segregated depending on waste type and their properties. Waste storage areas were all covered and bunded to provide a suitable level of secondary containment.

The only area of note was the acid waste storage unit, which was a self-bunded metal container. Some corrosion was visible to the external areas of the container, the operator is advised to inspect the container for integrity on a regular basis to ensure that containment has not been compromised.
