### 4. Details of our assessment

#### Site Report

A routine compliance assessment check carried out on 01/05/24. NRW Environment officers Callum Murray, Ceri Malone, Emily Roe and Senior Environment Officer Natlalie Wrangham were present, alongside a DCWW Pollution Technician. We were unable to access the CSO at No 7 Sanderling Close, Porthcaw, as the cover required a two person lift and there was only 1 DCWW pollution technician present. On the 14/05/24, NRW were

sent a dated photograph of the CSO from DCWW. This showed a screen present, with minimal debris meaning the CSO was compliant with section 2.3.2 (d) of the permit.

It was noted that the EDM returns for EPR permit BB3694HN CSO at No 7 Sanderling Close, Porthcawl, were missing from your 2023 EDM Bathing Water Returns.

In accordance with the permit condition 4.4.2, the annual EDM returns for this site for 2023 should have been submitted by the end of February 2024. Therefore, as of the 1st of March 2024, a non-compliance occurred.

Actions – please carry out the actions specified above to comply with permit condition 4.2.2.

1. Report the missing 2023 EDM data to NRW.
2. Ensure data is supplied in the 2024 EDM returns.

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
