4. Details of our assessment

Biffa Waste Services Limited

EPR/CB3394CM

A pre-operational measure was issued within the permit, which is detailed in Table S1.4A. The measure required a revised fire prevention and mitigation (FPMP) plan to be submitted to NRW at least 4 months before the site is brought online. PO1 included four outstanding issues, these are detailed below.

1. Final location of Drum Crusher, Shredder and other plant equipment.

The FPMP now includes the location of the drum crusher, which is to be located in bay 11.

2. Emergency plan for site to be reviewed and revised as appropriate.

Updated emergency plan has been submitted, the plan is detailed in appendix FPMP 7.

3. Any update(s) to the firefighting strategy out of operational hours.

Out of hours response is detailed in section 4.9.6 of the FPMP, with additional information provided in appendix FPMP6 and FPMP5.

4. Details on specification of the CCTV systems put in place for detection. (such as CCTV visual flame detection systems, spark, infrared and ultraviolet detection.

The CCTV specification has been received. The specification meets the requirements for fire detection, with system being capable of temperature and smoke detection.

The submitted documents are accepted and the pre-operational measures – PO1 is considered complete.

Please note an improvement condition (IC 1) is still active and will need addressing within six months of the operation commencing. Please keep NRW updated with the progress of the site and the date that operations are due to commence.
