4. Details of our assessment

On the 12th of April 2024, Environment Officers Callum BRANNAN and Amy CHISNELL carried out a site audit on Mold Football CSO as part of the planned Mold Intermittent audits. Officers were accompanied by DCWW Pollution Technicians.

A visual check was made of the CSO against permit CM0031601. The CSO appeared to be in working order, with low flows on the day. There appeared to be no blockages in the channel and no build-up of rag and debris.



The CSO discharge point is located at SJ 23850 64700 on the afon Alyn. Due to the high flows, access to the outfall proved difficult. However there was no evidence that the CSO was discharging at the time and no pollution was identified in the watercourse.

Is this CSO part of the SOAF project for 2024?

A data request will be submitted, and an audit will follow.
