4. Details of our assessment

On the 12th of April 2024, Environment Officers Callum BRANNAN and Amy CHISNELL carried out a site audit on Mold Bryn Awelon CSO as part of the planned Mold Intermittent audits. Officers were accompanied by DCWW Pollution Technicians.

A visual check was made of the CSO against permit CM0167901. The CSO appeared to be in working order, with low flows on the day. The mechanical screen operating as designed with no evidence of solids built up on the screen.

There was slight evidence of grease and fats build up within the CSO chamber and along the inside walls. Please see image below. The cleaning of the chamber was discussed on site and has been logged as an action.



The outfall discharging into an unnamed trib of the Black Brook was not identified at SJ 24179 64658 due to restricted access. However the watercourse downstream of the discharge point didn't show any signs of pollution.

Is this CSO part of the SOAF project for 2024?

No further issues were noted on the day. A data audit will follow.
