4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine inspection at Bryn Posteg gas plant.

The Site Manager and Environmental Technician accompanied NRW officers during the inspection.

A new landfill gas engine had recently been installed at the site and it was currently at the commissioning stage. The Site Manager estimated that it would be another 1-2 weeks before the engine was fully operational.

The landfill gas flare was operational and burning landfill gas while the new engine was being commissioned.

Action 1- Operator to notify NRW once the new landfill gas engine is fully operational.
