3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

In 2022 a variation to the discharge permit for the wastewater treatment works was initiated under the AMP6 FLOW4 driver. As part of this variation the operator (DCWW) also requested the addition of UWWTR conditions for a WwTW serving a PE of between 200 and 10000, discharging to freshwaters.

As stated in summary section above, the following non-compliances with the permit are being investigated:

- **Condition 3.3.1** - *The operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit: (a) point source emissions specified in tables S3.1 and S3.4; (b) inlet quality specified in tables S3.1 and S3.4* - There are 6 sampling shortfalls. There was a failure to return to "normal frequency" when the UWWTD conditions were added to the permit 05/06/2023. No formal agreement was requested/made to pause monitoring any part of the permit, specifically in schedule 3.
- **Condition 4.3.6** - *For the activity A1, referenced in schedule 1, table S1.1, the*

operator shall inform Natural Resources Wales in writing of any change, or proposed change, to the population equivalent such as would make a material change to the application of the Regulations and shall, on request, inform the Natural Resources Wales in writing of the actual population equivalent. - No updated population equivalent figures have been provided in line with the agreed PE procedures, despite Hirwaun WTW being part of the Hirwaun WWTW load for many years.

Actions

- NRW to be notified of monitoring schedule in accordance with permit condition before monitoring period start, unless a request is made and agreed that monitoring is not required at this time - **by 30/06/2024**
- Confirmation of PE to be submitted and approved by NRW - **by 30/06/2024**
