4. Details of our assessment

On Friday the 17th of May 2024 Ian Thomas, waste regulation officer carried out a routine, unannounced inspection. The weather was dry and sunny. The officer was met by Mr Richard Tomlinson, site owner. Mr Richard Tomlinson showed the officer around.

The AD plant is still solely using waste produced from the farm and does not accept waste from outside sources.

The AD plant tanks and feedstock were checked and found to be in good working order with no signs of any issues – cracks or structural damage. The surrounding concreted area had some waste that had been pushed over into the bunded area, with a small section of the concrete bund wall removed to gain access for machinery to remove the waste. Richard explained that this would be cleared promptly and the bunded concrete wall placed back. The mixing facility also appeared to be in good order. A brief check was made of the levels within the AD which all appeared to be appropriate. Good records were also kept of the waste input in the AD diary located in the control room. Overall site was in excellent condition with no issues to be highlighted.

The gas plant was checked and was in good working order, constantly producing power which is added to the grid.

Checks carried out prior to the inspection showed that waste returns have not been submitted since 2022.

Waste returns: Section 4.2.2 of the site permit states that "Within one month of the end of each quarter, the operator shall submit to NRW using the form made available for the purpose, the information specified in the form relating to the site and the waste accepted and removed from it during the previous quarter.

Action Please submit the missing waste returns by 30th June 2024.

It is understood that no waste is received from any outside source, but the condition to submit timely waste returns with zero waste accepted/removed on site is a requirement of the permit.
