At 8:15am on 29th August 2019 Newport Wafer Fab (NWF) informed Natural Resources Wales (NRW) that a gasket had failed on a compressed air supply line on the roof of Fab 10, resulting in a noise emission of 110 decibels. The noise went on for approximately five hours before the pipe was isolated and the gasket replaced. NWF informed Newport City Council in case any local residents had complained. NRW also informed their Incident Control Centre. No complaints were received by either organisation.

NRW received the Schedule 1 Notification on 30th August 2019, detailing the cause of the problem, immediate remedial action and maintenance works planned for the December shutdown to ensure that the same failure does not recur.

Since no complaints were received about the noise, NRW will not be issuing a non-compliance for this breach of a permit condition. This may change if further information comes to light in the future.
