4. Details of our assessment

Liz Park (Senior Officer - Waste Regulation) and Luke Taylor (Officer - Waste Regulation) undertook a site inspection following the serving of a Regulation 37 Suspension Notice at Palleg Landfill Phase II operated by JLA Disposal Ltd (BT1908IX) as it is known from the site's waste returns and management system that waste from the Bulky Waste Recycling Centre is transferred to Palleg Landfill Phase II. At the time of the inspection the weather was cool and dry but there had been recent heavy rain.

(W2A) Permitted activities - Assessed

At the time of the inspection no waste was in the 'Area B- Lower Level Wastes'. The bay was empty with a large pool of standing water.

Management System

The management system that NRW hold on file is 'JLA Recycling working plan v6 22_10_2022'. If this is the current management system it must be updated in light of the adjacent landfill being unable to accept waste for disposal. Please review section 2.1.2.1. and provided an updated management system to NRW for review by Friday 7 June 2024.

If it has already been reviewed and updated, please provide a copy to NRW for review by Friday 7 June 2024.

The Management system refers to '*The general layout of the transfer station and the location of waste storage types within the facility as shown on Figure 4 which is located at the end of the written text of this document*'.
