This CAR form is with regards the Event Duration Monitoring (EDM) conditions of the permit.

It's noted that the EDM equipment was operational for 38% of the year. The minimum requirement is 90%. A comment regarding Comms failure/issue has been quoted as the reason for this shortfall.
