4. Details of our assessment

The purpose of this inspection was to update Natural Resources Wales (NRW) on GDE's present activities and future developments prior to Rebecca Green's retirement.

Future Regulation of the Site

RVG explained future arrangements for regulation of the site. GDE now have a good compliance record and, in NRW's opinion, the site's operations pose a small risk to the environment.

Consequently, GDE will not, at present, have a designated site officer. They have received an email detailing future arrangements and should continue to send all monitoring data to Liz Parr. If any guidance is required, GDE should email the IR SE team inbox (details in the email already sent).

Business Update

The variation to add some new waste codes to the permit has been duly made and should be issued in the middle of July. GDE were warned that there are significant delays in the permitting process at the moment, although this variation should not be affected.

The wash plant is still in the commissioning phase. There have been problems with the pump and filter cloths in the filter press.

Business is quite steady. GDE are concentrating on septic tank wastes, oily wastes and gully wastes. They are not treating leachates and have no immediate plans to do this, due to the difficulties it can cause in the treatment plant.

Monitoring and Reporting

Monitoring and reporting requirements were discussed. GDE are fully compliant.

Site Inspection

The site was clean and tidy. The heavy rainfall last year and into the beginning of 2024 has not caused any problems on the site because GDE keep the drains and interceptors very clean.

Some of the bays constructed to hold the output from the wash plant are being used to store IBCs containing segregated waste. IBCs containing this waste are also stored in various places around the site. Labelling is not sufficient on some containers. **See Action IR2C above.**

NRW appreciate the open and co-operative relationship that has been developed with GDE and hope that this will continue into the future.
