## 4. Details of our assessment

On Friday 10<sup>th</sup> May 2024 Waste Regulation officer Chris Burge and Enforcement Apprentice Mark O’Gorman attended at Lower Yard (Unit 13) Star Trading Estate, Ponthir Road, Caerleon, Newport, NP18 1PQ. Permit EPR- EPR-DP3793VH.

The site was locked and secure, and no waste operations were taking place at the time of the inspection.

### **Permit Breach**

According to NRW records, the last submitted waste return for this permit was Quarter 2, 2016

W4B - Reporting to Natural Resources Wales – Category 4

Breach - Permit Condition 4.2.2

“Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter”.

Quarterly returns are required as by the permit conditions.

## Important information
