## 4. Details of our assessment

### Cefn Mawr Poultry Farm site inspection

Peter Jones attended the site on Tuesday 28 May 2024 and met with the site manager.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the people/property/environment
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

### Site Report

The inspection involved of visual inspection of infrastructure and drainage and a review of documents required under the permit conditions.

A visual inspection of the yards surrounding the sheds was made with concentration on state of the concrete surfaces and drainage. There were no issues identified with roof and yard drainage or the drainage used to divert dirty wash water to collection tanks during cleaning. The holding tanks are emptied by Gamber Logistics.

The issues raised in the previous site inspection on the 17 June 2021, regarding nutrients entering the settlement pond has been resolved and all the onsite drainage ditches were running clear and looked to be free of contaminants.

Overall, the concrete yard is in good condition, though the concrete is beginning to break up at the entrance

to shed No. 3 and will require some maintenance soon.

The site was clean and tidy and there were no reports of noise or odour complaints.

Following the site inspection, the officer proceeded to the site office to inspect documents required under the permit conditions, these were all in order and available for inspection. The inspection centred around the BAT conclusion replies submitted to Natural Resources Wales earlier in 2021 as a permit requirement. There were no issues with these, and the BAT techniques being carried out were approved.
