4. Details of our assessment

The purpose of this inspection was to update Natural Resources Wales (NRW) on Vishay's present activities and future developments prior to Rebecca Green's retirement. Future arrangements for regulation of the site were explained. Vishay's compliance record is generally good and, in NRW's opinion, the site's operations pose a small risk to the environment. Vishay will not, at present, have a designated site officer. Relevant personnel in NRW have been informed of their future plans and the importance of not hindering any future developments has been emphasised. Vishay have received an email detailing future arrangements and should continue to send all monitoring data to Liz Parr.

The site was not inspected during this visit.

SU will be leaving Vishay soon and future correspondence from NRW should be sent to DW, with a copy to AL, until a replacement Environmental Engineer is in post.

Since buying the site in March, Vishay have developed their long-term investment plan for the site. It involves considerable financial expenditure which could result in significant increases in staff numbers.

The first stage of this investment has started with the installation of new equipment. This will progress into extending the manufacturing space within one of the existing buildings and will not require a variation to the existing permit.

Phases 2 and 3 of this investment will involve higher capital expenditure and are therefore scheduled to occur over a longer time period.

Vishay will need to apply for a permit variation once the start date for Phase 2 of the development has been approved by their management.

NRW appreciate the open and co-operative relationship that has been developed with Vishay over many years and hope that this will continue into the future.
