ACTIONS:

The site has reported the above listed breaches of perimeter monitoring wells on the Eastern boundary of Phase 1 outside the the permitted time limit as stated in schedule 6 - within 24 hours of detection. FCC have submitted the following findings and actions in accordance with the revised Gas Management Plan:

Works in area to improve suction. Extra monitoring taken place. Boreholes re monitored (highlighted in yellow above) and confirmed boreholes are now back within permit limits

FURTHER ACTIONS REQUIRED:

These actions were expedited and reported with some delays and not entirely in accordance with the permit conditions and the Gas Management Plan in addition the breaches were not reported within 24 hours.. Therefore a score of CCS3 has been applied for a minor breach of perimeter gas trigger levels and a score of CCS3 for late reporting of this breach.

As the perimeter wells in phase 1 still show great sensitivity to the gas control system, this should be taken into account when reporting any breaches and particularly during engine maintenance and any

flare switchover and precautionary additional monitoring undertaken during these events.
