- No odour issues were present at the time of visiting the site.
- The sample point is from the downstream side of a weir in the channel below the

reed bed, this weir needs to be regularly maintained and we ask that it is inspected every month to ensure it has not silted up or moved.

- Pro Waste undertake a de sludge of the plant twice yearly – **please produce confirmation of the previous two years de sludging activities.**
- **Please produce Plant service records for the previous two years**, we believe ExCal do this for you.
- We understand the reedbed is maintained every four years – **please produce evidence of the most recent maintenance visit.**
- **Please confirm UV process details and process limits, as per Table S3.3b of the permit**
