4. Details of our assessment

On 15 April 2024 a sample taken at Abercych WWTW returned a result for BOD of 27 mg/l against a permit limit of 20 mg/l.

Email received from DCWW on 31 May 2024

DCWW believe the sample exceedance at Abercych was caused by solids carryover into the final settlement tank. This was due to routine tasks being carried out on the Hodwax on the final settlement tank. The routine task needs to be carried out to remove the accumulated solids however this can disturb the solids and take longer for them to settle.

Since the failure DCWW have removed the Hodwax system and done some modifications on site around how they run the final tanks with silt buster and how they manage sludge more effectively.
