### **Site Visit Comments**

Environment Officer Emma Tucny attended Cottrell Park Golf Club on 26/07/2019 to assess Water Abstraction Licence 21/58/21/0024. The sites General Manager led myself around the site.

Upon arrival, the General Manager explained that the abstraction has not been in use since last year and they have been meaning to revoke the licence.

Meter readings were recorded every day between April and September up until August 2018. These were made easily available for inspection. The final meter reading on record was 27787 cubic meters, which is well within the maximum quantities specified in the licence.

The abstraction point was situated at the location detailed in the permit. The meter also read the same reading as in the records.

The licence was compliant so there will be no actions. We have also received confirmation that the licence has now been revoked.
