### 4. Details of our assessment

**Site Report**

Inspection carried out at Taff Bargoed Minewater Remediation Scheme for discharge permits AN0319501 (discharge 1, Upper) and AN0350601 (discharge 2, lower), and water resources abstraction licence WA0570021001.

The weather was overcast with periodic drizzle.

Present were 3 members of the coal authority including the operational manager of the CA sites in Wales, and Environment Officers from NRW.

During the site walkover the CA explained that some reedbeds had recently been replaced in accordance with their maintenance schedule.

No discolouration was observed from either discharge at the time of inspection. Both discharges were screened with a bar screen (see images below).
