## 4. Details of our assessment

Unannounced site inspection undertaken by Jolene Lewis and Michael Edwards of Natural Resources Wales.

### **General Management - (W1A)**

Officers requested copies of EMS and permit; however, these documents were not available to staff at the time of the inspection. Under **condition 1.1.3** Any person having duties that are or may be affected by the matters set out in these standard rules shall have convenient access to a copy of them kept at or near the place where those duties are carried out.

This has been scored as a category 3 breach of permit condition 1.1.3

**Action** - as discussed on site ensure that all members of staff whose duties are affected by the environmental permit have convenient access to a copy as required under 1.1.3

### **Operations (W2A) (W2C) (W2D) (W2E)**

Activities on site were in accordance with table 2.3. under condition 2.3.1

Site drains were clear of debris and flowing smoothly during inspection.

Containment of stored materials were appropriately stored and segregated. Storage bays were utilised and were well marked.

Gas cylinders were not in a locked secured cage.

**Action** – as discussed on site, gas cylinders need to be stored in a locked and secured cage.

### **Emissions and monitoring (W3C)**

The site was free from odour emissions during visit.
