## 4. Details of our assessment

On Wednesday 1st May 2024, Luke Taylor (Waste Regulation Officer) and Chris Gilbey (Tackling Waste Crime Officer) of Natural Resources Wales (NRW), attended The Smithy in Aberarth to conduct a routine compliance inspection.

The weather at the time of the visit was dry and overcast, with no wind.

### **General Observations**

On arrival at the site the main gate was closed and secured, with the site appearing to no longer be operational. It was possible to see through the side of the gate and the site appeared to have been mostly cleared since the time of the last inspection in October 2023. The two portacabins have been removed from site, along with a partly de-polluted bus, with only the remains of the weighbridge and a skip of waste tyres in the bottom part of the site still remaining. This skip will need to be removed if the site is no longer processing waste, and taken to a suitably authorised facility to be disposed of. There was no evidence of any debris or litter escaping from the site and the carriageway outside

If the intention is to surrender the permit for the site, please submit a surrender application to NRW, with the required supporting documentation, and this can then be processed. Whilst the permit is still in place the site will still be subject to annual subsistence fees, payable to NRW.
