Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

This Compliance Assessment Report follows a visit to Brookhill Landfill with NRW's Landfill Emissions Reduction Project team (LERP). The LERP team undertook a gas audit of the in-waste wells. A separate report will be issued relating to their findings. A site inspection was undertaken at the same time as the audit.

The Operator confirmed that in waste gas wells had been sealed using bentonite during quarter 1 2024.

Leachate from Standard landfill is treated at the site alongside Brookhill landfill's leachate through the leachate treatment plant. The Operator stated that they are looking to replace the aging leachate tanks at the site. Vegetation was noted where the roof of the holding tank meets the concrete structure.

Action 1: Maintenance should be undertaken on the tank to ensure the integrity of the tank is maintained.

Clinical waste bins, containing yellow bag waste and sharps containers, were being stored on site at the time of the visit. It was unclear how long this waste had been on site or when this waste was due to be moved off site.

Following the inspection the Operator supplied a Hazardous Waste Consignment Note dated 04/05/2024 showing that clinical waste had been delivered to Tradebe Healthcare in Wrexham. EWC 20 01 99 was referenced. The permit does not allow for this waste to be stored at site. **A category 3 breach of condition 2.5.1 against criteria IR2H waste acceptance has been applied.**

Action 2: Any remaining clinical waste stored on site should be removed off site immediately.

Action 3: The Operator should review their clinical waste storage procedures to ensure that waste not detailed in Schedule 2 is not stored on site.

Officers also reviewed the location of the recent trial pit investigation and nearby boreholes.

Action 4: Off site borehole GW4 should be raised to avoid surface water run-off into the borehole and possible contamination. The Operator should review the status of all boreholes to ensure they are not being impacted by surface water run-off.
