4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Jolene Lewis of Natural Resources Wales.

General Management (W1A)

Waste was stored appropriately on the yard within designated skips and concrete bays, all waste was on impermeable surface with appropriate drainage in line with **condition 1.1.1** of the permit.

Wastes identified during the inspection were in compliance with **condition 1.2.1**.

A copy of the permit and working plan were available in the main office in line with **condition 1.4.2**.

Waste Operations (W2A, W2C, W2D)

All wastes were stored appropriately on impermeable surfaces as required under **condition 2.1.1** of the permit.



As discussed on site, the drainage system near the storage bays require cleaning with a

potential blockage. This water was collected at another drain on site. However, as discussed on site, ensure that the drainage systems are maintained as required under **condition 2.1.2** .



Emissions and Monitoring (W3A)

During the inspection no issues were identified from mud or debris leaving the permit boundary in line with **conditions 4.1.1** and **4.1.2**. With no evidence of dusts or particles being generated and escaping from the site as required under **conditions 6.1.1** and **6.1.2**.

Notifications (W4C)

Following the inspection NRW received notification that Kevin Jones would no longer be continuing as the TCM for this site.
