NRW officers given a site walkover by Coal authority operative, weather was overcast. Site appeared well maintained. Site uses aeration process, polishing occurs in the reedbeds before discharging back into the watercourse.

It was noted that some reeds are due to be replaced shortly.

No discolouration was observed from the discharge point at the time of inspection
