Dragon Recycling Solutions are planning to move to a new site which they hope to occupy in about year to eighteen months. This visit was inspect the site for any existing environmental problems.

The building is much larger than their existing premises but will need extensive internal modifications before it is suitable for Dragon's purposes. The concrete floors will need repairing and sealing to ensure they are impervious, but overall the buildings seem to be in reasonable condition.

Once planning permission has been granted Dragon would be well advised to do some dye tracing so that they can discover which drains (foul and surface water) are connected and where they discharge.

There are several buildings outside which Dragon intend to use for storage of waste, as well as other purposes. This will be a big improvement over the present site where some waste is stored outside in the yard surrounding the building.

The surfaces outside are in reasonable condition, all having impervious surfaces, but these would also benefit from some improvement and repair.

Opportunities for the installation of renewable and/or more efficient energy sources were discussed. Dragon have employed a consultant to advise them.
