#### Query over asbestos disposal

This concerned an annual tonnage of 42 tonnes of asbestos to Docks Way landfill. WWOE consider that this is likely to be from rejected loads and will confirm this in due course. The issue of contaminated incoming green waste was acknowledged by WWOE and they have been in regular discussion with Cardiff CC to try and resolve the issue. This included giving training to council enforcement officers on which wastes are acceptable.
