ACTIONS:

FCC (The Operator), has reported the above listed breach of a perimeter monitoring well on the Eastern boundary of Phase 1 of the site outside the permitted time schedule, stated in schedule 6 as within 24 hours of detection. The permit breach notification was submitted the following day but not within the 24-hour limit. The location of this well is in a critical migration pathway area and therefore should be reported immediately as specified in the Landfill Gas management Plan V7. However due to the personnel changes at FCC the changes to the GMP were not referenced and so any delay will not be scored on this occasion.

FCC have submitted the following findings and actions:

Gas contractor (Infinis) notified and instructed to check all infrastructure in the area, report any faults and make necessary adjustments/ repairs/ remediations. BH to be re monitored following any works. BH03 has been checked by Infinis and is now clear showing 0% CH4, our monitoring contractors are due out early next week to once again check

FURTHER ACTIONS REQUIRED:

These actions were not expedited entirely in accordance with the permit conditions and the latest Gas Management Plan V7.

Please ensure all such breaches are reported and actioned in accordance with permit conditions and the site Gas Management Plan (V7)

A score of CCS3 has been applied for a minor breach of perimeter gas trigger levels. As this is a sensitive

area this score may be increased if permit and management plans are not followed, following such a breach in the future.

As the perimeter wells in phase 1 still show great sensitivity to the gas control system, this should be taken into account during engine maintenance and any flare switchover and precautionary additional monitoring undertaken during these events.
