4. Details of our assessment

This compliance assessment report has been produced to detail our enforcement response to the Category 2 breach/non-compliance observed on 21st September 2023, recorded on CAR_NRW0042767.

A site inspection was conducted on the 21st September 2023 to assess compliance against the permit, as outlined within CAR_NRW0042767, re-issued following appeal and review on 23/02/2024 and then re-issued to correct a permit condition referenced on 12/06/2024.

In line with our enforcement and sanctions policy, having considered our enforcement response, we are issuing you, the operator, with a Warning letter on this occasion for the Category 2 non-compliance with permit conditions 1.1.1, 2.3.1, 2.3.2 (consolidated) & root cause of 2.1.1.

A warning letter has been served alongside this Compliance Assessment Report, which is as detailed below.

Warning Letter

Further to Natural Resources Wales's EPR compliance visit to Project Red Recycling Limited, Heol Creigiau, Efail Isaf, Pontypridd, R.C.T CF38 1BG on 21st September 2023. I now write to update you. NRW have identified the following offence:

Offence

It is an offence to contravene The Environmental Permitting (England and Wales) Regulations 2010.

Contrary to Regulation 38 (2) It is an offence for a person to fail to comply with or to contravene an environmental permit condition.

The above offence relates to the consolidated category 2 non-compliance breach identified with permit conditions 2.3.1 and 2.3.2, 1.1.1, and for the root cause breach for the subsequent breach identified under permit condition 2.1.1. outlined in Compliance Assessment Report CAR_NRW0042767 reissued 12/06/2024. Conditions 2.3.1 and 2.3.2 relating to waste acceptance were breached, as well as the conditions of RD051, as waste was accepted without the relevant checks being performed, in contrary to the requirements of Regulatory Decision 051.

On this occasion we are issuing you a **warning letter** as a response to the above offence. However, our decision could change if any further relevant information comes to light, including, but not restricted to, information that:

- you have committed earlier offences
- the environmental impacts of these offences are greater than we presently understand them
- the offences are continuing or have been repeated
- you have committed other offences of which we are presently unaware.

We will take this offence into account if we consider that you are involved in any future offending.

This warning does not:

- prevent any other prosecuting authority taking action against you/the Company; or
- affect our right to issue enforcement, clear-up or remediation notices, or seek recovery of costs or damages according to law.

Important information

Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
