4. Details of our assessment

WARNING

On 4th March 2024 a routine sample was taken at the permitted discharge point.

Analysis showed that the level of suspended solids breached that of the permitted limit.
Permit condition 3.1 - Emissions to water.
3.1.2 - the limits given in schedule 3 shall not be exceeded.
Schedule 3 - limit for suspended solids is **50mg/L**.

Result - 95mg/L suspended solids.

Therefore this Compliance Assessment Report contains a warning.

Further routine samples were taken in April and May, both of which were compliant with permit conditions.

I am aware that there were issues with the underground tanks at this site and adjustments were made to the volume treated by the silt-buster which may have been the cause of the breach. Please ensure you continue to monitor the outfall and take actions to prevent a recurrence.
