Unannounced site inspection undertaken by Jolene Lewis, Michael Edwards, and Hugh Martin of Natural Resources Wales.

General Management (W1A)

Officers requested a copy of the permit and TCM. The permit was made available and TCM was recently updated, and proof shown via mobile.

Action – Leanne Jones to send a screenshot of her TCM Certification, for records to be updated.

Operations (W2A), (W2C), (W2D), (W2E)

Activities on site were in accordance with table 2.1 in the handling and treatment of end-of-life vehicles.

Table 3.1 requires sealed sumps shall be inspected daily and after heavy rainfall and records of these activities keep in a site diary or maintenance log.

Maintenance was currently being done on the water drainage system; however, flow was still being sent to the sealed drainage system that is inspected on the daily walk rounds.

Impermeable pavements were in good condition and regularly checked and repaired in accordance with Table 3.1

Site infrastructure was good and in accordance with permit section 4, secured boundary and identification board present and correct with permit conditions.

Action- To send photographic evidence of completed drainage systems once completed.

Information (W4A)

Permit was on site and present when officers requested.

Records of drainage daily monitoring was kept digitally but presented when officer asked for it.
