4. Details of our assessment

An unannounced site inspection was undertaken of Recresco Limited by Senior Waste Regulation Officer, Jodie Baskerville and South East Waste Regulation Team Leader, David Griffiths following receipt of a number of odour complaints. The weather at the time of the inspection was dry and sunny.

A full inspection was not carried out at this time due to officers being there in an incident response capacity and not routine regulatory work.

Incident Response

Several reports of a "diesel" type odour were received by Natural Resources Wales during the week commencing 6th May 2024. (WIRS (Wales Incident Reporting System) Master record 2406706) This odour was believed to be emanating from the Recresco facility in Cwmbran.

Having been met on site by an employee of Recresco Limited, we were escorted via the main glass processing building to the drying part of the plant, the location of which the odour was believed to be coming from. The site was operational at this time.

In order for the glass to be processed it needs to be completely dry. This is done by putting it through a large heater. Steam or vapour from the drying process is emitted via a chimney stack and in certain weather conditions can appear like smoke. The heater on site is currently fuelled by diesel but plans are in place to move this over to gas, with an estimated completion date of the end of July.

Condition 3.2.1 of the environmental permit states;

"Emissions from the activities shall be free from odour at levels likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales, unless the operator has used appropriate measures, including, but not limited to, those specified in an odour management plan, to prevent or where that is not practicable to minimise the odour."

During the inspection, no mal odours or unusual emissions were witnessed, therefore no breach of this condition will be recorded. The investigation into the reports associated with the master WIRS record detailed above will be marked as un-substantiated and closed.
