4. Details of our assessment

NRW received an exceedance notification from Dwr Cymru (DCWW) for Holt WWTW on 15/5/2024 and the 20/5/24. The final effluent sample taken on 7/5/24 and the 10/5/24 exceeded the look up table limit on the permit.

On the 7th May 2024, the sample resulted in a BOD result of 41mg/l (the permit limit is 40mg/l) on the 7/5/24. This is the 1st exceedance for BOD at this site within the last 12 month period

On the 10th May 2024, the sample resulted in a BOD result of 46mg/l (the permit limit is 40mg/l). This is the 2nd exceedance for BOD at this site within the last 12 month period.

On the 17th June 2024, DCWW provided an explanation for the exceedance:

there were 2 BOD sample failures in short succession which we have attributed to the biological treatment capacity, both filters have now been overhauled with new distributors and site is performing much better.

The site permit changed in February to see stricter sanitary limits which site had been achieving prior to the failures; BOD is not a sample that can be carried out on site by the operational team and so the deterioration in this particular limit is less overt particularly when you take into account it was only in lower flows that the permit was not achieved. The change in weather to being slightly drier saw the biological treatment begin to reduce, it is worth noting that the failure results (41 and 46 mg/l) on a new permit of 40 mg/l are only just above permit. The biological filter work was on our forward looking programme to be completed and so we were able to mobilise quickly once we saw this change and performance has been stable since.
