## 4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards, Jolene Lewis and Hugh Martin of Natural Resources Wales, accompanied on site by Mathew Jones director of Pembrokeshire Metals Recycling Limited.

### **General Management (W1A)**

During the inspection, officers requested copies of the Permit and the Environmental Management System (EMS) which were provided as required under **condition 1.1.3** and were provided records of inspections undertaken by the operator as required under **condition 1.1.2**.

### **Waste Operations (W2A, W2C, W2D, W2E & W2F)**

Operations on site during the inspection were compliant with the activities listed in the permit under **Schedule 1 table S1.1**. With all wastes stored on impermeable surfaces with sealed drainage, depollution of ELVs only undertaken within the purpose built building and treatment of wastes limited to those described in **table S1.1**. However, concerns were raised during the inspection regarding the volume of waste on site.



Waste oils and liquids generated from the depollution process were stored in double bunded tanks stored within a secure bund which was noted to be in good condition. Depolluted engines were stored on impermeable surface with no evidence of oil leaks from the waste.



As discussed on site, it is important to maintain the sites infrastructure to ensure that possibility of pollutions are minimised.

During the previous inspection, a non-compliance was identified due to the use of a bailing machine on site, a permit variation has been submitted by the operator to allow this activity in future. This was not in use at the time of the inspection.

All waste activities were undertaken within the permitted boundary as required under **condition 2.2.1** and **Schedule 7**.

**Records (W4A)**

An action from the previous inspection was to submit missing waste returns required annually, under **condition 4.2.2**. This action has been completed.
