4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards, Hugh Martin and Jolene Lewis of Natural Resources Wales accompanied on site by Chris Hughes of Hughes and John Haulage.

General Management (W1A)

Officers requested a copy of the current environmental management systems (EMS) and a copy of the permit held by the site. Both documents were made available on request as required under **conditions 1.1.2** and **1.1.3**.

As discussed during the inspection, it is important that all members of staff on site who's role is affected by the permit have convenient access to these documents at all times.

Action - Please provide evidence of continuing competency as required under **condition 1.1.4** of the permit.

Waste Operations (W2A, W2C & W2D)

Operations conducted on site during the inspection were in accordance with **conditions 2.1.1** and **table S1.1** of the environmental permit. With treatment limited to sorting, screening, separation, crushing and blending during the time of the inspection. All within the permitted boundary of the site as required under **condition 2.1** and **schedule 7** of the permit.



Wastes identified were in accordance with the permitted waste types allowed under **condition 2.3.2 (a)** and **table S2.1**.



Emissions and Monitoring (W3B, W3C & W3D)

During the inspection officers noted no issues relating to emissions limit set in the permit under **conditions 3.1**, and no issue relating to odours (**condition 3.2.1**) or noise and vibration (**condition 3.3.1**) at level that would likely cause pollution were raised during the inspection.
