#### **SUMMARY OF ISSUES FOR COMPLIANCE FOLLOW UP**

##### 1. GAS MONITORING BOREHOLES

The breaches of gas monitoring boreholes on parts of the perimeter have been highlighted for investigation.

A query was raised regarding the placement of the boreholes and whether they were 'in waste' or very close to waste.

An investigation has been undertaken using excavation trenches to establish the boundaries of the waste and therefore any issues with migration.

Following the investigation a decision will be made about future scoring of any migration in these areas.

##### 2. LEACHATE LEVELS

Final report and action plan to be submitted within two weeks of the date of this CAR form

Must contain pumping trail details and action plan for assessment of leachate head and recovery across the site.

Scoring regime will be re-assessed following this process

##### 3. CULVERT -EMERGENCY PLAN

Dry weather flow/high rainfall flow in the stream must be utilised as a function of the hydraulic loading when designing emergency response to the culvert blocking or collapsing.

Include a standby pumped trial
