3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Routine inspection of sewage treatment system serving the Llanwenarth Hotel and Riverside Restaurant. The discharge consists of domestic sewage effluent with a maximum daily discharge volume of 5.4 cubic metres to an infiltration system.

Mrs Akan explained the system is desludged on a regular basis by GD Environmental Service Ltd.

Access to the treatment plant and effluent sampling point is currently limited due to the prolific plant growth. Easy access should always be available to the effluent sampling point. The undergrowth should be

cut back as soon as is reasonably practicable. Condition 3.3 of the permit requires permanent access to the sampling chamber.

At the time of the visit there was a piece of hardboard covering the access hatch to the treatment plant. I did not remove the hard board to check because of the plant growth, but if the manhole lid has been damaged it should be replaced as soon as possible. See attached photograph.

A visual inspection was carried out and there was no evidence of effluent breaking out of the treatment system nor were there any unpleasant odours coming from the system. A sample of the final effluent was not taken on this occasion.

Just to remind you, It's important you keep a record of desludging, or any maintenance carried out on the system. Your permit requires your records are retained for at least 6 years.

Please ensure the vegetation is cut back to provide access to the sample chamber as soon as possible and if required replace the manhole cover for the treatment plant.
