4. Details of our assessment

This was an unannounced site inspection carried out by Senior Environment Officer Steven White. On arrival at the site entrance the gates were padlocked and as such a physical site inspection was unable to be carried out, subsequently a desktop study of previous Waste Returns was carried out.

Previous CAR forms indicated that the site is close to reaching its permit and Waste Recovery Plan limits, as such very little waste has been accepted onto site. The nature of the permit (Deposit for Recovery) is such that minimal waste would be removed anyway off site.

Waste Return checks show that in 2023 no waste was accepted onto site and 0.66T was removed. Q1 2024 showed that 17.62T (equivalent to one wagon) was accepted, no waste was removed.

There are no concerns with site operations, no incidents have been reported to Natural Resources Wales regarding this site since the previous inspection on 19/08/2022.
