4. Details of our assessment

An announced, routine site inspection was undertaken on Wednesday 5th June 2024 at TBS Waste Transfer Station, Plot 10. Present at the time of the site inspection were David Ellar (Natural Resources Wales), Rachel Mallinson (Natural Resources Wales), Llyr Samuel (Natural Resources Wales) Amy Thomas (TBS), Dave MacKay (TBS) and Stephen Thomas (TBS).

The site operates under a Standard Rules Permit SR2008No3 a Household, Commercial and Industrial Waste Transfer Station with Treatment.

The weather was fine and dry.

The purpose of the inspection was to assess compliance against conditions of the Environmental Permit (Ref: EPR/VP3598FA)

General Observations:

Storage of waste:

Generally, there was good segregation of waste types observed however the site seemed busier than normal and waste stockpiles were over spilling their bays. The operator explained that issues at receiving sites had caused a backup of waste at the site but did not see it as an issue as other waste receiving options were available.

Site infrastructure:

The roof was still in need of repair following the fire incident that took place in August 2022. The internal walls appeared to be damaged and also needs to be repaired.

Permit breaches identified:

W2A - Permitted activities – Permit Condition 2.3.1 and table 2.3 – CAT 3 non-compliance.

Permit condition 2.3.1 (table 2.3) states:

Unless stored or treated outside as specified waste - all bulking, transfer or treatment of

waste shall be carried out inside a building.

Waste, mainly farm plastic was observed being stored in an area where the roof had been damaged and removed. This is a breach of the permit and has been recorded as a category 3 non-compliance. This breach was also note don our last CAR ref: CAR_NRW0042470

ACTION: Unless stored or treated outside as specified waste - all bulking, transfer or treatment of waste shall be carried out inside a building. Please ensure all waste is stored in accordance with the permit.
