4. Details of our assessment

On Thursday the 14th of December 2023 Natural Resources Wales officers attended site.

This was a routine site inspection for permit ref EPR/CB3491FL which was carried out by Waste Regulation Officer Ian Thomas.

On arrival at site, Ian met with Gavin Shepherd, site manager, who accompanied the officer throughout the visit.

Inspection of the outside area of the site showed a measured improvement. The containers and IBC's that were stored have been completely removed.

Part of the storage area was outside of the permit boundary and was close to the public footpath and road, this area has been totally cleared which was very good to see. The storage is now managed and is within the permit boundary.

The outside wash plant is being utilised as storage, again this is within the permit boundary and the wash plant has no plans to be operational.

The first site inspection was carried out on the 21st of June 2022, at this time aspects of the permit including submitting waste returns, permit variations, public register details etc were explained. Waste returns for the site must be completed within one month of each quarter. Checks prior to the visit showed that no waste returns had been completed since the permit was issued. **Permit condition 4.2.2: Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter. Compliance criteria G4 - Scored as C4.**

During the last visit in December 2023 the same issue was highlighted on the CARS form, and to date no waste returns have been submitted.

All operations are taking place within the building, as specified in the permit. The building contains areas for both recycling and manufacture of new containers. A newer process within the wash plant is cleaning perfume containers, which seems to be a permanent contract.

The permit was granted with a condition that fire walls would be installed within the waste storage areas 1, 2, 3 and 4. These walls have not been installed. It was requested in the previous CAR form that, "A report confirming these have been installed and to the correct specification must be submitted to Natural Resources Wales for written approval". This subject was raised on the last CARS form in December 2023. Gavin explained that the installation of the required fire walls is imminent, the fire breaks have all been ordered and delivery/fitting will be completed in the next few weeks. Please forward completion details to NRW upon installation of the fire breaks.
