4. Details of our assessment

Unannounced site inspection undertaken by Jolene Lewis and David Morgan of Natural Resources Wales.

General Management (W1A)

Officers requested a copy of the Environmental Permit and Environmental Management System. The permit was made available but was not easily located.

Action- To ensure all staff have access to Environmental Permit and Environmental Management System and are aware of their responsibilities. As per permit conditions 1.4.1

Operations (W2A) (W2C) (W2D)

The site, generally, appears to be well maintained although following an inspection of drainage channels there was some litter found. Ensure litter checks are carried out to avoid blockage of the drainage systems. This was not an issue at the time of inspection, but it is good practice to check to prevent issues in the future.

All wastes appeared to be segregated appropriately and waste types on site were in line with permit condition 4.4.

Site security and boundary line was checked and in good condition at time of inspection.

At time of inspection the site was free of mud and debris as per condition 4.1

Emissions and Monitoring (W3E)

Litter around boundary kept to a minimum, recommended daily checks to ensure litter does not escape boundary. As per condition 6.5.1 monitoring and control of litter from the confines of the site.



No breaches were identified during site inspection. Overall, the site was clean and tidy, with good separation of waste. Ensure drainage systems and boundaries are checked and well maintain to prevent issues arising in the future. To ensure all staff are aware of the location of Environmental Permit and Environmental Management System. The security and boundary were checked and in good condition at time of inspection.
