4. Details of our assessment

This was a routine unannounced compliance visit carried out by Malcolm Dines (Waste Regulation Officer) and Gillian Coates (Hazardous Waste Officer) who met with site staff who were available to discuss any matters during the site visit. All documents required were made available.

Permit Breaches

W1A - General Management - Cat 3; Permit Condition 1.1.1

You have been given this category 3 breach under the above permit condition because the waste cooking oil is stored in 220 litre drums that do not have secondary containment. Your standard rules permit requires you to operate in accordance with Generic Risk Assessment (GRA1) which requires all liquids, whether or not they are waste, to be stored with secondary containment.

Action: Ensure that all liquids are provided with secondary containment **by 1 August 2024**

Other Matters

During the inspection of the containers on-site some wastes were in the wrong skip, for instance a television in the scrap metal skip. The site operatives explained that they were aware of the television and that it had been deposited earlier that day, but because of the location of the television in the skip, for health and safety reasons it would be difficult to remove while the site was open and so would be removed once the site closed. The staff explained that they do routine checks of the skips and remove incorrectly deposited wastes, but if wastes are not removed quickly, on a busy day it would be easy to see incorrectly deposited wastes becoming inaccessible without first emptying the entire skip. You should consider alternative processes for removing incorrectly deposited wastes at the earliest opportunity once staff become aware of the issue.
