4. Details of our assessment

This CAR form has been issued in response to the submission of the Q1 2024 monitoring returns by the operator. The returns were submitted on 26 April 2024, within the reporting period specified in permit condition 4.2.3 Reporting.

At the request of the operator, the initially submitted Forms Air 1 Continuous were withdrawn and resubmitted on 9 May 2024.

Forms Air 1 Continuous, Residue 1 and Performance 1 were submitted and reported emissions and other parameters were within emission limits specified in the permit for the Q1 monitoring period.

A separate Form Air 17 was received from the operator on 26 April 2024, including the half yearly extractive spot sample measurements for emission point A1. The reported emissions were within emission limits specified in the permit.
