4. Details of our assessment

Routine site inspection by environment officers Peter Jones and Holly Sisley, of the sewage pumping station serving Magor Motorway Services, M4 junction 23, South Wales. The permit authorises the discharge of sewage during an emergency.

The sewage pumping station looks to have been neglected for some time. The main entrance to the site was open and a side door on the main building, leading to a small room had been forced open. Please see attached photographs.

The oil Storage tank looks to have been damaged and it's not clear if it's still in use. The housing for the Yara Nutriox equipment has been broken into. The equipment was serviced by Yarra on the 14 May 24. Please see attached photographs.

The main building was locked and looked to be secure.

The discharge point listed in the permit looks to be incorrect, I have attached a map showing the location of the sewage pumping station and the listed discharge point.

I have attached a copy of the Environmental permit AN0259201 for your information.
