4. Details of our assessment

This is a follow up from CAR_NRW0042476 and has been reissued to add an extension to the deadline for action 1.

For clarity, this CAR form refers to the operation of Event Duration Monitoring (EDM) equipment for this asset during 2022 but has been completed on the 30/04/2024

Condition 3.1.4 states that "The operator shall take appropriate measures to ensure that the event recorder remains fully operational at all times within the reference period specified in table S3.1. Any failures shall be remedied as soon as reasonably practicable".

The operational time for this asset was less than the minimum of 90%.

It was 8.22% operational and during this time there were no known spills.

The date range for unavailable data was 30/01/2022 - 31/12/2022.

Guidance for scoring the non-operational time suggests that this may have had a category 3 – a non-compliance that could have a minor impact on the environment.

DCWW were asked why this non-compliance occurred and what was done to resolve the issue(s).

The primary reason for the non-compliance was a sensor and outstation failure.

A new outstation has now been installed.

A request sent to operational staff at DCWW for information on the sensor replacement and a job card has been raised to have this work carried out.

Please provide an update on the replacement of the sensor.
