### 4. Details of our assessment

I attended site on 21<sup>st</sup> June at 13.30 where I met with Rob Isaac (Technical and Quality Manager) and David Stoneman (Quality Manager); thank you for your time during the visit. The weather was warm with sunny intervals.

Initial discussion was regarding the status of the permits for the site, including some historic permits that appeared to have been overlooked. 22/59/1/0102 was still associated with Highland Spring but may or may

no longer be accessible/useful – you have taken the decision to request it be transferred from Highland Spring which will enable you to investigate accordingly.

We then looked at the two boreholes (A + B), and the flow meters inside the factory. Only the one borehole is currently operational due to turbidity issues but works are ongoing to look at additional/replacement boreholes. There is a valid Groundwater Investigation Consent (GIC) for the site, to enable exploration of additional boreholes/abstraction quantities and assess any potential impacts to the water table. The site was not operating at the time of my visit so no flow was observed.

Summary of Actions:

- Confirm transfer of 22/59/1/0102 Crystal Falls Spring when complete to ensure completeness with Abstraction Returns and any other permit requirements.
- Complete abstraction returns for the relevant period (NB – this action is ongoing and in-hand).
