Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) following the submission of the Q1 Monitoring Returns.

Q1 Monitoring Returns (January to March 2024) - Emissions to Water

The Q1 Returns for January, February and March were submitted on 30/05/24. The late returns are a **breach of Condition 4.2.3 and have been scored a C4.**

January 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

February 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

March 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

ACTION 1: Returns are to be submitted as specified in Condition 4.2.3. *within 28 days of the end of the reporting period.*

Permit Variation Applications

A Medium Combustion Plant permit variation for the new boiler was issued on 25 March 2024 (permit version 003).

A permit variation application for the incorporation of Ferric Dosing System was submitted to NRW in December 2023. The Operator is still awaiting the application to be Duly Made. The application must be Determined prior the Ferric Dosing System being operational.
