The subject of this marine licence variation is regarding the replacement of the damaged Dolphin-U monopile at the Pembroke Dock Ferry Terminal.

This licence variation looks to update the method for construction of the replacement Pembroke Ferry Dock dolphin mooring which was damaged by the ferry in 2022. The design for the reconstructed dolphin mooring has changed since approval of the marine licence (CML2270) from one 2.1m diameter pile to five individual 0.6m piles. Milford Haven Port Authority are also requesting that the licence expiry date is extended to December 2025.

To easily identify the proposed changes to the activity, we have 'track changed' the original licence application and attached it to this variation request as well as a note which further clarifies how the proposed changes to the dolphin design do not affect the assessment provided with the original application, or require any changes to the conditions on the licence.

The original WFD will also not be affected by the licence variation.
