4. Details of our assessment

This Compliance Assessment Report (CAR) details the comments of Natural Resources Wales (NRW) Officers for the site inspection conducted on 22 May 2024 at BOC Limited, Margam Gases, Longlands Lane, Margam, Port Talbot, SA13 2NS, for activities held by BOC Limited (the operator) under the environmental permit ERP-BV9713IU.

The visit purpose was to conduct an introductory inspection of the site and handover regulatory duties to Senior Regulatory Officer Rhydian COX. No non-compliance scores were recorded against the operator's permit conditions on this inspection.

Inspection Commentary

Arrived at site at 10:00. Greeted and signed in by the Regional SHEQ Advisor. Weather conditions were dry and overcast with light wind and good visibility. An open agenda was sent in advance of the site visit alongside a request for any additional topics for discussion. The site induction was sent by the Regional SHEQ Advisor and completed online in advance of the site visit.

A presentation was given on the history of the site, processes, environmental policy and compliance. Discussions were then had around the EPR Permit and consolidating the permit in light of the proposed changes to the the 'KTI plant' which had been mothballed since 2016 and is now scheduled for decommissioning. The current EPR permit boundary encompasses a relatively small section of the BOC Margam site to the NW of the site.

A site tour was then undertaken around the entirety of the site. This was in order to gain a better understanding of how the site operates and how all the areas are controlled and linked with each of the processes undertaken. The site tour continued to the two plants regulated under the EPR permit, the mothballed KTI plant and the Howmar plant, which remains operational and was at the time of the site visit. The Howmar plant was observed from a distance due to the requirement for specific non-sparking clothing and PPE.

Upon completion of the site tour, further discussions were then had around the site contact and personnel changes at the BOC Margam site. Responsibilities and the main site contact of the EPR permit now sit with the Environment and Sustainability Manager. Left site at 13:00.
